Bidder instructions can be found under "Part II: Instructions to Bidders". Read and follow the instructions as written. In addition, be sure to read through the entire IFB to include but not limited to the "Part III: Scope of Work" and "Part IV: Bid Evaluation and Award" to ensure you include and comply with all requirements of the IFB.
2	14-Aug-23	B & B Concepts, Inc.	Your IFB states responsive bidders must bid on all items. Given the very diverse materials included in IFB DDBS017-23, is "no bid" on an individual item considered as a responsive bid?	Part IV: Bid Evaluation and Award, Item number 2. and Item number 7. states " <u>Bidders must bid on all line items.</u> Partial or incomplete bids will be rejected unless otherwise stated in the solicitation. There is no where in the solicitation that states otherwise, as such you must bid on all line items. Note: Incomplete bids are considered "non responsive".
3	16-Aug-23	B & B Concepts, Inc.	One last concern - Your IFB states unit prices must be firm and fixed for a period of 3 years. After reaching out to the various manufacturers of the items being bid, the market volatility at this point is not receptive to guaranteeing prices much more than 90 days, if that long. However, in the case where raw material is likely to be available and production costs are known, some manufacturing partners have indicated they will commit through June 2024. Will Prince George's County consider and allow JUSTIFIED documented price escalation after June 2024?	Part I: Introduction and Background, item number 7 states "The contract resulting from this solicitation shall be Firm Fixed Price ". The firm fixed price shall consider any potential cost increase or savings as it will remain fixed for the the contract term.
